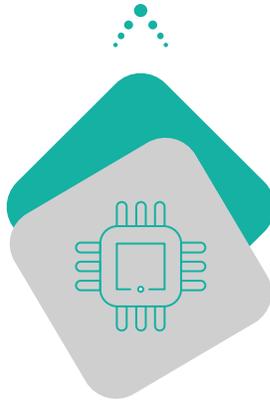
- Welcome to our second Gemini Sustain Plus Focus Group

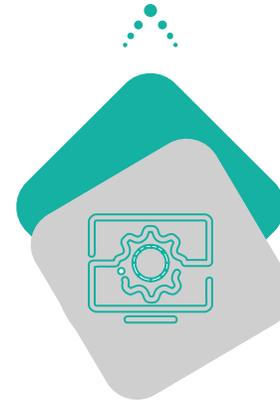

Sustain Plus Programme Overview

- We have completed 30% of Functional UAT of the screens and components.
- Continuing to progress development and testing for Capacity, Energy Balancing and Invoicing processes.
- The interface design is understood, and the programme are working on the solution definition for the new Gemini platform to minimise the external impact
- The programme is looking into the design of the contingency arrangements that will support the new Gemini platform.
- Training content has continued to be developed. The new Gemini UI E-module will be ready for training release in Q2 2024 in preparation for Market Trials.

Gemini Sustain Plus Benefits

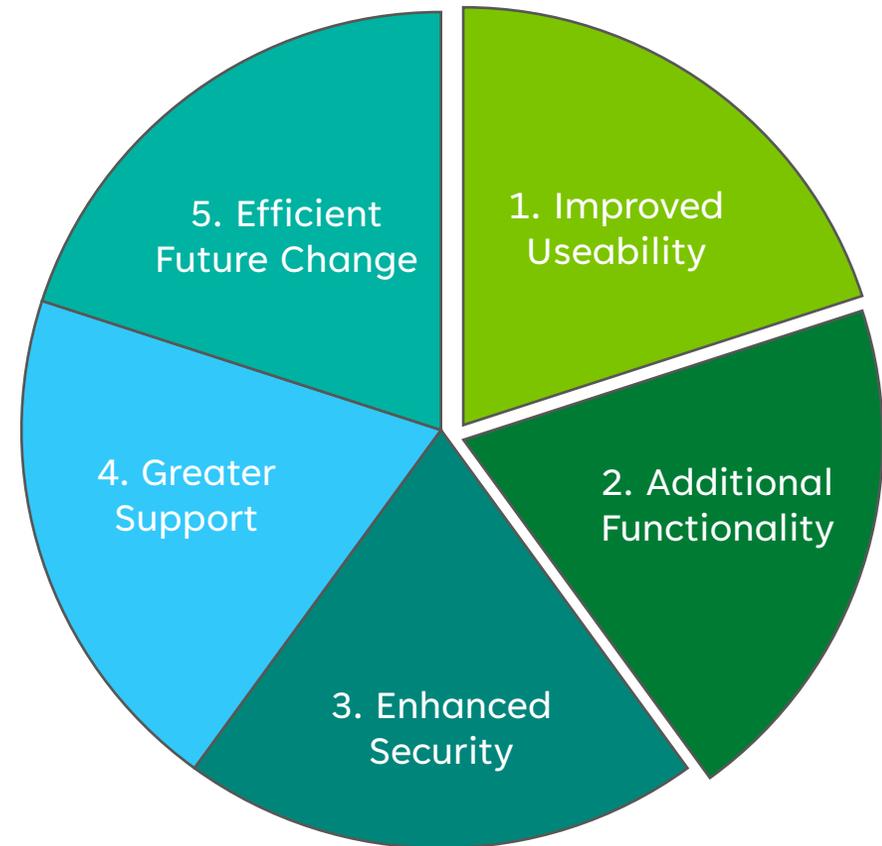
All Users to realise the benefits of Gemini Sustain Plus

Improved Usability

- Fresh modern user interface
- Easier and more intuitive to navigate
- Customisable landing page and favourites

Improved Useability: New Gemini Log-In

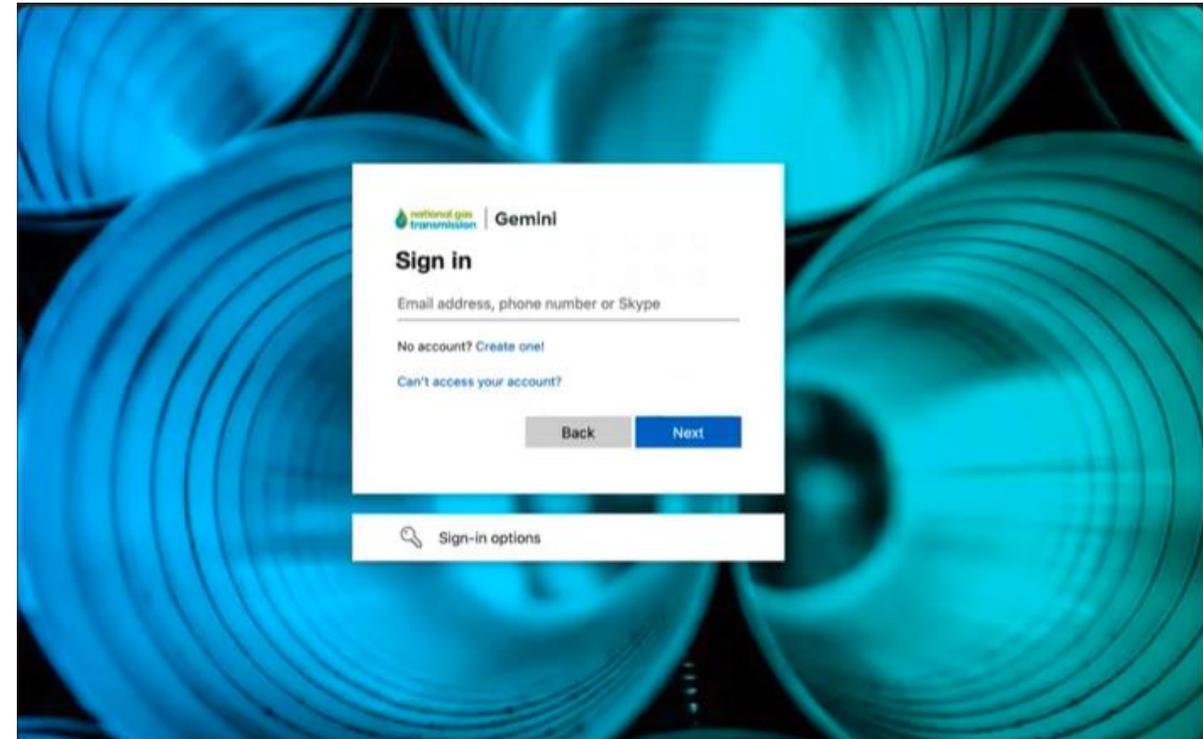
Benefits

- Gemini will be assessable over the internet
- Federated security, will mean there will only one login required to access the system
- Accessible via different web browsers and via mobile devices
- Simpler and easier to access the platform
- Federated security allows more ownership through Local Security Officers

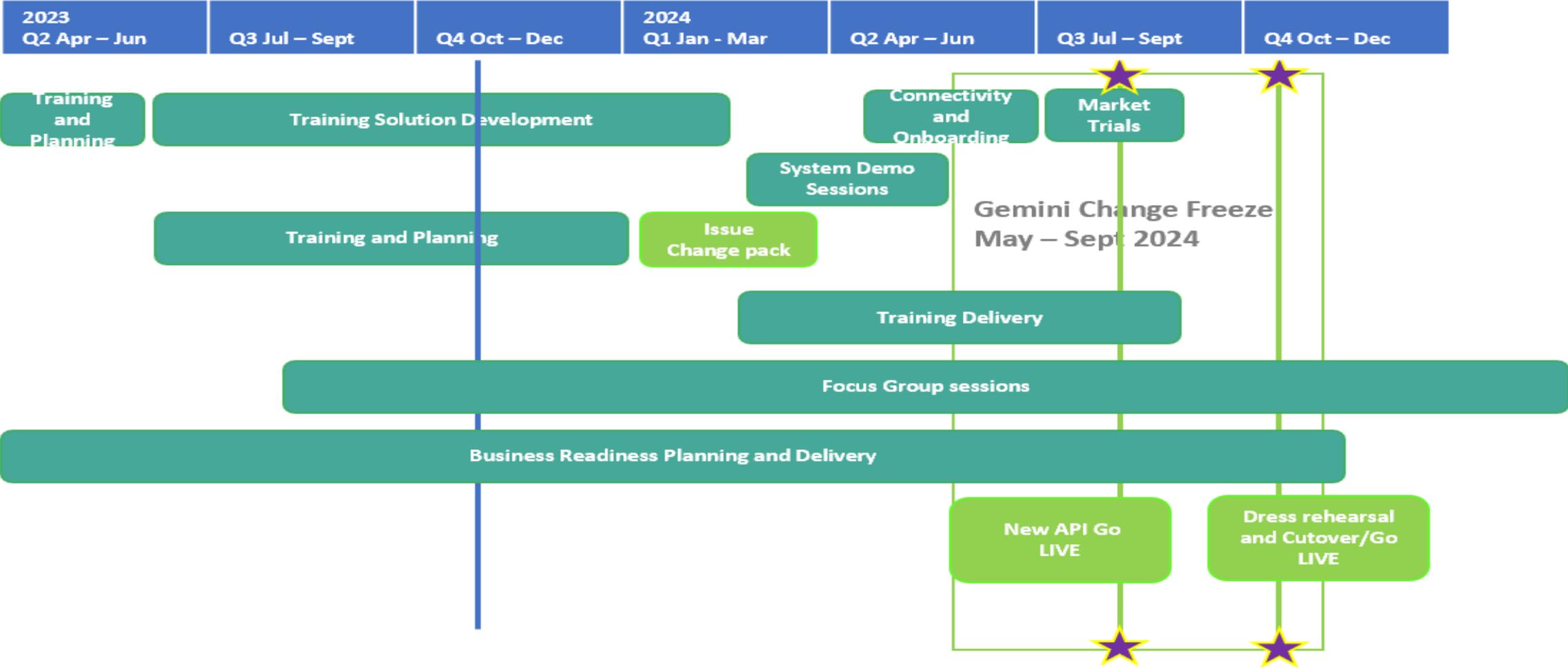
Important Information

- **Every** current user of Gemini will require a **new User ID** before go-live
- A full Gemini user audit will be undertaken in the coming months to support that transition process

Connect to the New Gemini Platform

- Connect to the New Gemini Market Trials and Production environments via the new URL and IP details to reach the landing page
- Ensure that BAU systems are fully connected ready for Market Trials and Go-live



Register for the New Gemini Platform

- Ensure that all Gemini Users know their user IDs and can log into the New Gemini Platform



Impacts

- If organisations do not take part in connectivity testing, at go-live they will not be able to log into the Gemini system at all. There will be no dual running of the old and new Gemini systems.

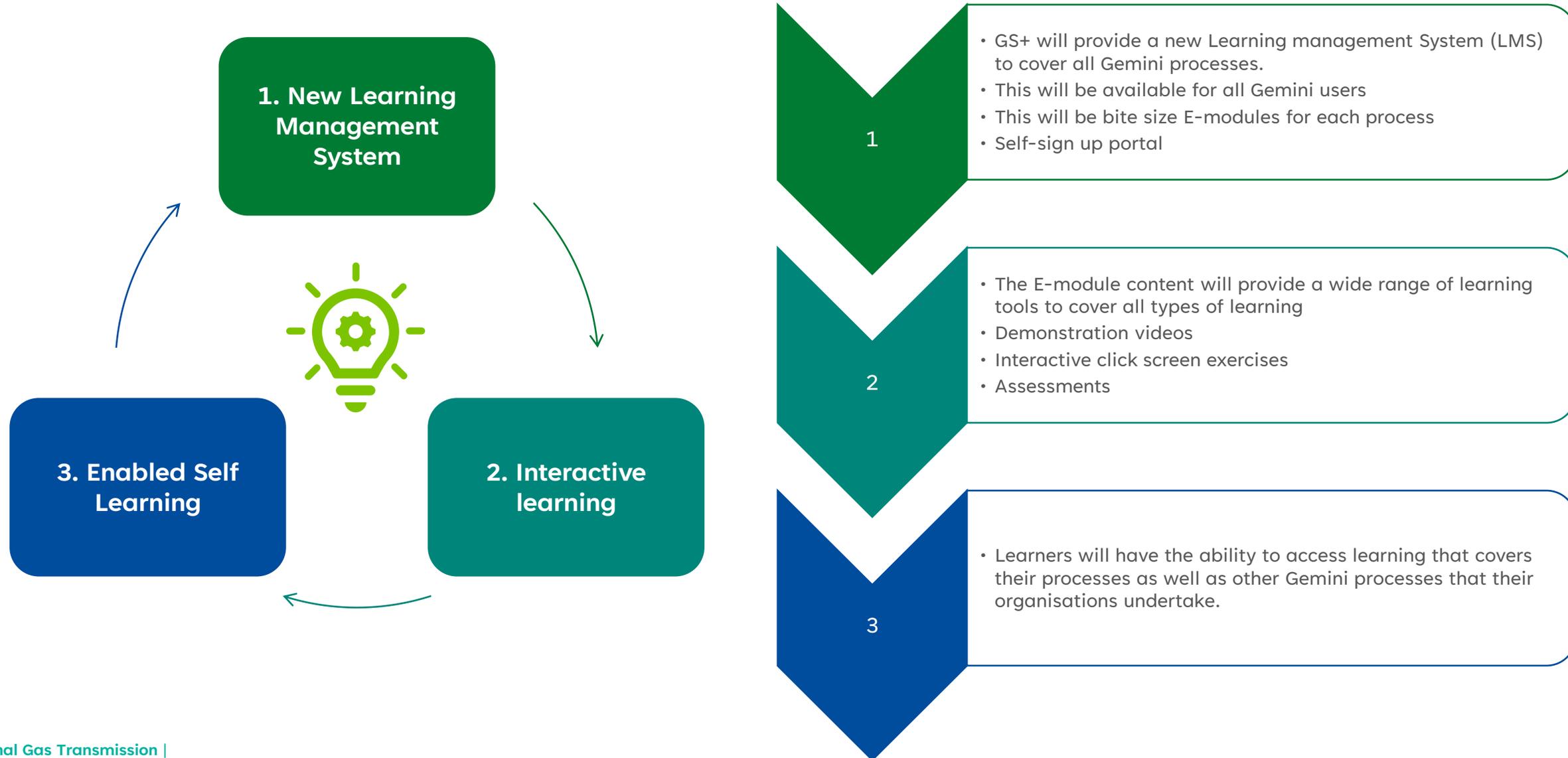


This gives the industry a chance to familiarise themselves with the New Gemini system UI and navigation menu.

API Changes

WHAT

- A new API gateway is being introduced to support both the existing APIs and to provide all new API functionality introduced when the cutover to the Gemini Sustain Plus platform takes place
- The new gateway will support both XML and JSON requests for existing APIs and will deliver other enhancements in security, performance, compatibility and availability

WHEN

- The new API gateway will be made available for testing during the Market Trials period in Q2 2024
- Following testing, the new API gateway will be made available for customers to fully transition to, this API transition can take place prior to the main Gemini Sustain Plus cutover planned in Sept 24
- This approach is aimed at providing customers an extended transition period to test and move to the new API gateway (soft cutover approach) in advance of the main Gemini Sustain Plus cutover

PREPARATION

- Technical details of the new API gateway, its connectivity requirements and other pertinent information will be made available ASAP, this will be shared in advance of the Market Trials testing

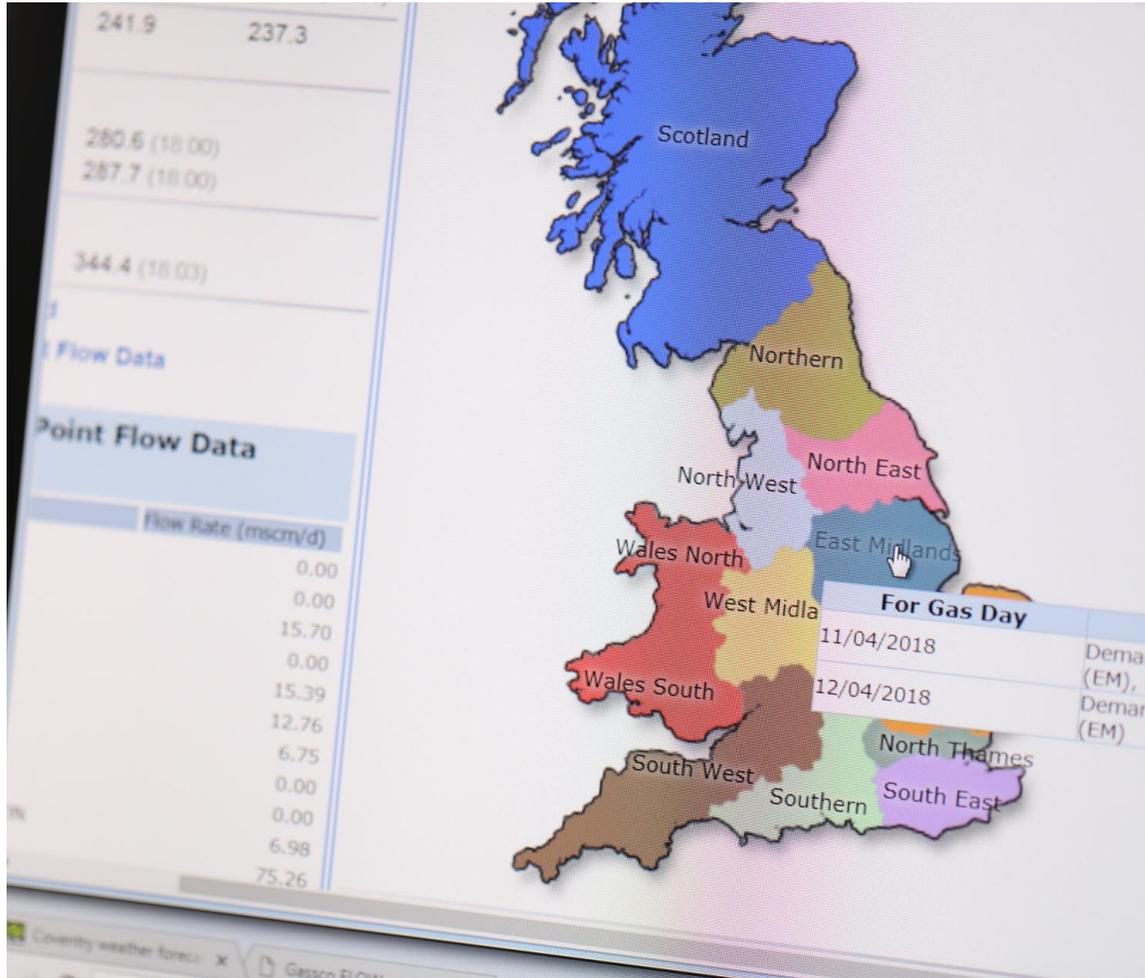
